Maya Alieh completed 21 years in the Montreal Police Department (MPD). Starting as a patrolman for a couple of years, she has also worked as an undercover agent, a vice squad investigator and has made her way to the High Tech Crime Unit more than 12 years ago. Having found her niche while realizing the rapid evolution of technology and the difficulties law enforcement are presently facing, Detective-Sergeant Alieh proceeded to put in place training sessions for all investigators regarding cybercrime and cyber related investigations. Her work in cybercrime and up-to-date knowledge allowed her to become an expert witness when testifying in criminal cases as well as a mentor for general investigation around her police department.

In 2015, she was tasked to lead a team intended to provide new policy on internet and social media use for all police and civilian members of the MPD. Two years later, in 2017, she is ready to lead the newly created Cybercrime Module which she still is to this day while being in charge of providing full training for all detectives in her organization.

Aside from being involved within her department, Maya Alieh is an active member of several National committees and working groups regarding online undercover work, investigation and cyber security. She is also in charge of the covert online training given by the National Police Academy to newly appointed undercover agents in the Province of Quebec and cyber investigation training for all major crime detectives across Canada.

In her spare time, she is also a speaker on cybercrime and social media, has now given hundreds of conferences on related subjects and acts as a spokesperson for the Montreal Police Department on the matter.

He has represented a variety of clients in coverage claims, and provides valuation, coverage and resolution strategy services to insurers and insureds.

In resolving abuse claims, Michael uses his extensive knowledge, expertise and his proprietary database to determine fair and just claim valuations. During the resolution process, he treats survivors of abuse with empathy, respect and compassion, and helps them to understand their claim valuation and the factors that comprise it. He works to keep the process non-adversarial, and survivors frequently comment that they feel “heard” and cared about in the process. Michael seeks to assist organizations in eliminating sexual misconduct and helps them to identify gaps in protocol so that opportunities for misconduct can be eradicated. In his work, he helps to prevent or significantly reduce sexual abuse in institutions and society, and the enormous associated human and financial costs.

Jordan Greenbaum, MD is a child abuse physician in Atlanta, GA in the U.S. She received her degree from Yale School of Medicine and has worked in the field of child maltreatment for over 20 years. She is the Global Medical Director at the International Centre for Missing & Exploited Children and managed the Institute on Healthcare and Human Trafficking at the Stephanie Blank Center for Safe and Healthy Children at Children's Healthcare of Atlanta. She co-chairs the Human Trafficking committee for the Ray Helfer Society and is past co-chair of the Education/Training committee for HEAL Trafficking, an organization of medical professionals working on human trafficking issues.

Dr. Greenbaum has served on national committees and workgroups regarding human trafficking and has testified for Congressional committees. She co-authored a clinical report and a policy statement regarding child trafficking for the American Academy of Pediatrics.

Dr. Greenbaum provides training on human trafficking and exploitation and other aspects of child maltreatment for medical and nonmedical professionals. She trains locally, nationally, and internationally, working with child-serving professionals to prevent, identify and intervene in cases of suspected child abuse and trafficking. Her research focuses on developing and validating a screening tool to identify suspected child sex trafficking in the healthcare setting and on global healthcare for survivors of child trafficking.
